(1) include an appeal process for a person disqualified under (a) of this section; and

(2) provide that, where available, an alcohol safety action program approved under AS 47.37.130 shall perform the drug testing.

(c) In this section, "public assistance" means

(1) a program that provides

(A) day care assistance under AS 47.25.001 - 47.25.095;

(B) general relief assistance under AS 47.25.120 - 300; or

(C) adult public assistance under AS 47.25.430 - 47.25.615;

(2) the Alaska affordable heating program under AS 47.25.621 - 47.25.626; or

(3) the food stamp program under AS 47.25.975 - 47.25.990."
